June 25, 2010

The Board of Lake County Commissioners met in Special Session on June 25, 2010 at 2:00 p.m. with the following members present: Dan Bohl, Chris Giles, Roger Hageman, Bert Verhey, Shelli Gust State's Atty legal assistant, Tim Walburg Deputy Sheriff and Auditor Kay A. Schmidt. Chairman Verhey called the meeting to order.

Motion Bohl, second Hageman approves agenda of June 25, 2010. Motion carried.

APPROVE AUCTION:
